It's the children who are most affected by this... and they need your help.

"Children are often hungry because their families are unable to support them. We have a school feeding program, but this is not sufficient to meet the needs of the children from all 78 households in the village," says Jimmy Ngulube, a Head Teacher in rural Northern Zambia.

Chalenga, a women's group leader in the same village, adds, "We have challenges in our homes. We women do the farming, but it is the men who take the harvest." Unfortunately, many men then spend the harvest income on drinking and there is none left for the family's needs, like food and school uniforms.

The pandemic lockdowns dealt long-term serious blows to the local economies in AID's partner countries from which most have not recovered. Economic problems exacerbate other problems such as alcoholism, family violence, internal displacement, and community conflict.

This is why we need your support.

AID's Gender Equality Project funds programs that teach men and women about the laws relating to Gender-based Violence in Zambia, provides counselling and reporting services, and sets up small village savings and loans groups so that husbands and wives can work together to get the best outcomes for themselves and their children.

But Zambia is not alone. Similar post-pandemic economic disruption is being felt in the other countries where AID works with our church partners, including Kenya, Sri Lanka, the Philippines, Myanmar, and countries of the Pacific Islands.

In the Philippines, for example, the loss of tourism has combined with high debt levels to increase inflation. This means for ordinary people the price of necessities such as rice and bread have greatly increased, leaving them with very little, if any, food. In Kenya and Sri Lanka, the poorest people are paying the price of massive infrastructure debts incurred by national governments. And in Myanmar the ongoing political situation ensures that people continue to struggle to feed themselves and their children.

The worst of the health impacts of the pandemic may be over, but the communities that AID serves still have a long way to go before they are back on track to experiencing the human flourishing that Jesus promised us: "I came that they may have life and have it abundantly."
