Our long-standing partners, the Diocese of Jerusalem and the Church of the Province of Myanmar, have continued to minister amid the devastation of war and the displacement of thousands. Their unwavering commitment to saving lives and offering both spiritual and material support to those who have lost everything is nothing short of heroic. Through your generous support, AID has helped provide humanitarian relief to over 5,000 people in Myanmar and more than 4,000 individuals in Gaza and the West Bank. We give thanks to God for our partners, their courageous communities, and for the compassion of our supporters who make this work possible.

The past year also marked the beginning of a promising new partnership with the dioceses of Colombo and Kurunegala in the Church of Ceylon (Sri Lanka). Our inaugural pilgrimage to Sri Lanka in August 2024 was a deeply enriching experience, allowing us to support two new education initiatives in Kurunegala and witness first hand the transformative outreach of the Diocese of Colombo in rural communities. These pilgrimages are more than journeys—they are bridges of understanding and solidarity, and we look forward to continuing them.

Across all our partnerships, your support has helped AID reach more than 43,000 people—supporting them to improve their lives with dignity and hope. This is the fruit of shared mission, and we are deeply grateful.

As we prepare to celebrate ABM's 175th anniversary on October 29, 2025, we have spent the past year in prayerful reflection. The ABM Board has engaged in workshops and

consultations to discern how we can faithfully align our future with God's purpose. This process is shaping a bold new strategic plan—one that will guide our mission for the next 25 years.

One of the most exciting outcomes of this re-envisioning is the launch of the Bishop Arthur Malcolm First Nations' Bishops' Fund. Named in honour of Australia's first Aboriginal bishop, this fund will support the ministry of First Nations Anglican Bishops, helping amplify their voices and leadership across the Church.

Throughout this journey, we have been continually uplifted by the prayerfulness, generosity, and engagement of our supporters. Your responses to ABM's study and reflection resources have been deeply moving, affirming their role in offering fresh insights into scripture and the five marks of mission. Your presence in our celebrations and your commitment to our shared work are a source of great encouragement.

As we look ahead, we ask you to continue praying for us and for all our partners. May we remain faithful to the call of love, hope, and justice—together.

TRUTH-TELLING AND RECONCILIATION MISSIONER'S REPORT

First Nations Christians

One of my initial priorities has been to review and refine the language we use to ensure it reflects care, respect, and contemporary understanding. While the terms *Aboriginal* and/or *Torres Strait Islander* remain appropriate and are used interchangeably, the term **First Nations** is increasingly recognised as a more inclusive and globally understood reference to Indigenous Australians. This terminology is also widely accepted within both our communities and government contexts.

The term **First Nations Christians** reflects a multi-denominational faith community. It acknowledges the diversity of Christian expression among Indigenous peoples and ensures that our approach to ministry, care, reconciliation, and partnership remains inclusive and collaborative across different denominations.

NT Partnership Conference

The Northern Territory Partnership Conference was held over three days and brought together partners from organisations across Australia. Some partners are already investing in the Anglican Diocese of the Northern Territory, while others expressed interest in developing future partnerships to support the diocese's ongoing work.

During the conference, I visited Nungalinya College and met with several NATSIAC members who are both students and teachers at the college. Currently, there are 77 Anglican students attending the College.

The Anglican Diocese of the Northern Territory expressed deep gratitude to ABM for its continued support, particularly through the WALK program.

A key concern raised during discussions was the ongoing challenge faced by Indigenous clergy. Many have shared that funding is not reaching them directly for the significant work they do within their communities and the church. Due to cultural and language barriers, Indigenous clergy are often asked to take unpaid leave or volunteer their time, despite being central to the success of programs such as WALK.

Indigenous clergy are frequently tri-vocational—balancing church ministry, community responsibilities, work, and family commitments. It is therefore important that we consider mechanisms to ensure equitable access to funding and reduce the cultural load placed upon them.

Highlighting the Need for Resources for NAIDOC and Reconciliation Week

This year, I created several social media posts to acknowledge and highlight National Reconciliation Week. However, due to sorry business during NAIDOC Week, I was unable to produce or share content for that period.

Moving forward, I am exploring ways to strengthen our engagement during these two significant national events by developing a more coordinated and culturally informed approach.

NATSIAC Gathering 2025

The National Aboriginal and Torres Strait Islander Anglican Council (NATSIAC) Gathering 2025 was a significant event this year. With comments that 'this was the best NATSIAC gathering I've been to in a long time', the conversations felt more hope-filled than in previous years. ABM presented a report during the gathering, which was well received. NATSIAC members expressed their ongoing gratitude for ABM's partnership and for the continued support provided through my role within the organisation.

A highlight of the gathering was the ordination of Rev'd Lorryanne Smith, daughter of Bishop James and Auntie Lala Leftwich. The ordination was a deeply meaningful occasion for the Anglican Diocese of North Queensland, with NATSIAC executive clergy coming together to celebrate and affirm Rev'd Lorryanne's leadership. She is the deacon of Saint Luke's Aboriginal and Torres Strait Islander Anglican Ministry.

Discussions during the gathering also included the Bishop Arthur Malcolm Endowment Fund. We were honoured to have Ms Anne Hywood, General Secretary of the General Synod, and Bishop Matt Brain from the Diocese of Bendigo, who led a workshop on the evolving role of First Nations Bishop/s within the Anglican Church.

The naming of the Bishop Arthur Malcolm Endowment Fund was endorsed by NATSIAC members. Through their support, I contacted Bishop Malcolm's family and obtained permission to name the fund in his honour – this was well received by all First Nations members.

Bishop Chris McLeod announced at NATSIAC his intention to retire from his role as National Aboriginal and Torres Strait Islander Bishop sometime next year. As a result, NATSIAC will begin the process of identifying a new First Nations Bishop in 2026.

- Pacific Emerging Leaders' Summit (\$1,650),
- WALK (Diocese of the Northern Territory) (\$20,000), and
- NATSIAC Secretariat (\$18,00 over two years).
- Our Advent Appeal raised \$34,000 for Gawura School, and
- the Project Book raised \$25,000 for Nungalinga College.

EDUCATION MISSIONER'S REPORT

As always, ABM's Education and Resources Program provides a doorway through which supporters can walk to get a greater sense of what mission means in the twenty-first century.

In this year, while we have been preparing to celebrate – and celebrating – the 175th anniversary of ABM, we have also been thinking hard about what the future holds – and what part Education and Missional Resources play in that future.

Through our Visioning Retreats and conversations, it has emerged that a greater priority needs to be placed on these areas. This has meant a considerable amount of time being given to restructuring and dreaming about where we head from here. It is our desire to serve the Anglican Church (and others who use our resources) with authentically Australian, Gospel-focussed, creative missional resources that meet the needs of this time in history.

In the lead-up to Advent 2024, we produced 'CARAVAN', a story-based retelling of the Annunciation to Epiphany tales set in an Australian context. The response has been overwhelmingly positive.

The Right Rev'd Dr Anne van Gend, Bishop of Dunedin, literary scholar and writer, wrote, "I have read and watched many retellings of the Christmas stories, but this book is something special. The real

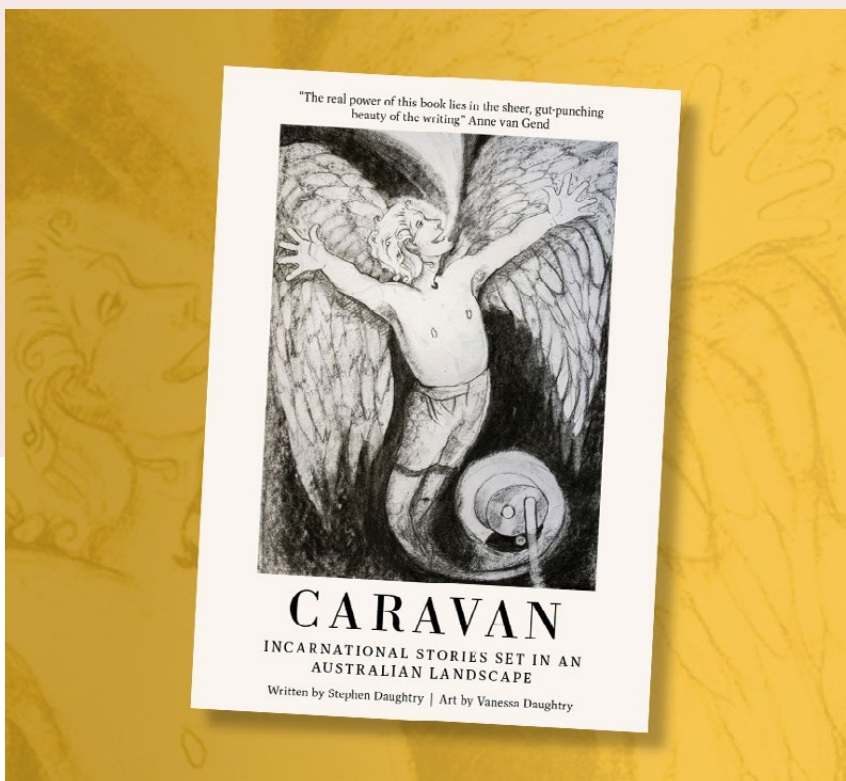
power of this book lies in the sheer, gut-punching beauty of the writing; the depth of character created in a few short paragraphs; the mystery that throbs through everyday people and places; and in the shared dawning wonder that maybe, just maybe, this unthinkable beautiful, far-away story of God coming to us is here, now, and real."

One group responded, "Our Uniting Church study group finished the last study yesterday and we all enjoyed the whole book so much. We found the texts and the way your stories gathered our thinking into the 21st century absolutely inspiring."

A companion volume will be released in Lent 2026.

Just as we are always trying to work with our Partners in Australia and Overseas with integrity, generosity, and innovation, we are also being called to nurture an inclusive, just, and exciting understanding of what God is doing in our own church and country.

Love, Hope, and Justice undergird everything that ABM and AID do in the service of God's mission to heal and reconcile all things.

CHURCH TO CHURCH OFFICER'S REPORT

ABM's Church to Church Program continues to work closely with Partners to support theological education and leadership development.

After years of dedicated effort, the Anglican Church of Papua New Guinea's Modawa Institute in Popondetta—the larger entity overseeing the Bishop of Newton School of Theology—is now officially registered as a higher education provider under the Department of Education, Research, Science and Technology. The School's November 2024 graduates were the first cohort to receive their certificate, diploma, and advanced diploma awards under the Institute. Notably, the advanced diploma graduates were the first at this level and are well-positioned for further studies.

The "Pathways" program welcomed around 20 students for a one-semester introduction to theology, with options to continue into certificate or diploma studies. A new intake of 17 ordinands and eight day-students from various dioceses has begun a two-year certificate in theology, which includes ordination formation and the option to progress to diploma level. Infrastructure upgrades, staff expansion, and compliance efforts are ongoing to ensure the delivery of high-quality education on par with national standards.

Similarly, St John the Evangelist Seminary in Zambia—also supported by ABM—serves as the country's sole Anglican theological institution. Excitingly, the Zambian church now accepts women for ordination. Two female candidates are currently in training, with one studying at St John's. The Seminary expects six fourth-year students to graduate in September 2025, alongside six second-year students continuing their formation.

These milestones reflect the strength of our partnerships and the faithful support of our donors and prayer community. Together, we're helping build resilient church leadership and theological institutions that serve their communities with wisdom and grace.

KEY RELATIONSHIPS MANAGER'S REPORT

As ABM prepares to celebrate its 175th anniversary on 29 October 2025, the Key Relationships Unit (KRU) continues to play its part in God's mission by thanking and encouraging those who support God's mission through ABM. Our current supporters are helping ensure the legacy of God's mission continues to bear fruit for the next 25 years.

In 2025, the KRU enabled participation in God's mission through:

Prayer

Supporters prayed with and for our partners using ABM's resources, including the weekly "Prayer for Myanmar" Facebook posts, fundraising appeals, and partner prayers. We also shared more urgent partner prayer requests via special Facebook posts and email messages.

Learning

In January 2025, we launched the new-look Project Book, *Love, Hope and Justice in Action*, highlighting our partners and their work. This new focus was reflected on ABM's website and in our monthly e-news, *On a Mission*, as well as printed updates sent three times a year. These stories inspired and informed, showing how supporters are making a difference. In-person events and the use of video conferencing technology allowed meaningful connections between ABM and our supporters.

Giving

ABM is grateful to the many supporters who give financially, especially those who have set up regular giving, allowing us to plan with confidence. Others gave of their time and talents, helping us do more with limited resources. We especially thank our Diocesan Representatives, ABM Committees, Auxiliaries, and Associates, true champions of ABM's mission. Stamp donations also continued to raise vital funds.

Going

After a four-year pause, ABM resumed its pilgrimages. In 2025, supporters visited Sri Lanka and the Philippines. Return trips are planned, and a new pilgrimage to the Solomon Islands is planned for July 2026. These small but significant steps aim to grow pilgrimages sustainably and support ABM's broader mission goals.

HEAD OF PROGRAMS' REPORT

Finally, a ceasefire between Palestine and Israel after two years of constant fighting and tens of thousands of lives lost. The world was relieved, and there is cautious hope that the peace deal will hold, and the process of rebuilding can begin. We have the same wish for Myanmar as elections have been set for December and January, which will hopefully bring about much-needed change in the country.

In 2025, the humanitarian disasters caused by conflict in Gaza and Myanmar continued to keep our attention as we maintained our support to our Anglican church partners in Jerusalem and Myanmar so that they can respond to the needs on the ground. We also responded to other disasters, including the earthquake in Myanmar and emergencies in Vanuatu, Mozambique, and the DR Congo.

Our Sustainable Communities Program reached at least 33,000 people, while our humanitarian response work reached more than 10,000 people during the year. Once again, our initiatives benefited more women and girls (53% of the total) in the last 12 months. More detailed results from selected program themes – Climate Resilience, Education & Training, Humanitarian Response, and Gender Equality – can be read in the next section of this report.

AID's new program strategy is focused on two key sectors: Education and Climate. We have started expanding our Education Program, supporting both formal schooling (mostly primary) and

informal training, including adult literacy activities. Climate resilience is a key theme that cuts across our WASH, agriculture, and livelihoods programs. Partners have already begun to align their programs with our new strategy.

Thank you to the Australian Aid program – the Australian NGO Cooperation Program (ANCP) and the PNG Church Partnership Program (CPP) – which provided funds for us to continue our community development programs in Papua New Guinea, the Philippines, Kenya, Zambia, and Vanuatu.

Our sincere gratitude to you, our donors, for your steadfast support. Your generosity motivates us to keep reaching out and partnering with communities that need encouragement and support to overcome challenges and look toward a brighter future.

Partnering with Churches and Communities to Transform Lives

In 2025, AID's community development program brought tangible hope to thousands across the globe. From solar panels powering water pumps and lighting community buildings in the Philippines to water tanks sustaining communities in Vanuatu, Myanmar, Kenya, and the Solomon Islands, our work helped meet urgent needs with lasting solutions. We supported drought-resilient farming in Kenya and the Philippines, nurtured savings groups in Zambia and beyond, and expanded access to education in places like PNG, Sri Lanka, and the West Bank. These efforts reflect our deep commitment to empowering communities through practical, life-changing partnerships.

In all, the program supported more than 33,000 people to improve their lives. Additionally, AID's humanitarian response program provided relief to over 10,000 people affected by conflict and natural disasters.

This year, we highlight our work with our partners across four areas: Climate Resilience, Education and Training, Humanitarian Response, and Gender.

AID's Sustainable Communities Program: Highlights of 2025

Climate resilience

Most of the communities that AID works with are farming communities. Farmers are particularly vulnerable to droughts, cyclonic winds, and erosion of topsoil and coastal plots.

In the Philippines, two of AID's projects (funded through the Australian NGO Cooperation Program and implemented by E-CARE and VIMROD) strengthened climate resilience through promoting drought-resistant crops – notably traditional varieties of rice and corn – and planting bamboo, mangroves, and other trees. E-CARE also installed solar panels in seven locations.

In Kenya, ADSE promoted drought-resistant crops such as cowpeas and mung beans. ADSE also planted trees and promoted water conservation technologies, including zai pits¹ and sand dams.

When ACOM in Vanuatu and the Solomon Islands ran awareness sessions on disaster preparedness, they included climate awareness. ACOM in the

Solomon Islands also equipped local communities with skills to collect climate change data and began building two sea walls—protective barriers designed to shield coastal areas from rising sea levels and storm surges—one in Honiara and another in the Diocese of Ysabel.

Education and training

AID's support for education programs is widening.

In 2025, we supported formal schools in Kenya (Eldoret Diocese), Palestine (the West Bank), Sri Lanka (Kurunegala Diocese), and the Philippines (Santiago Diocese), as well as providing scholarships, IT and maths classes in Sri Lanka (Colombo Diocese). We also continued to support adult literacy classes in Papua New Guinea and Vanuatu.

In addition, AID supported one-off trainings conducted by our partners in Zambia, Kenya, Sri Lanka, Myanmar, the Philippines, PNG, the Solomon Islands and Vanuatu. Topics included hygiene, plumbing, organic farming, disaster preparedness, group management skills, disabled people's rights, data collection, and gender awareness.

Ronald's story

Literacy is a vital skill and a stepping stone to further opportunities in life. In Papua New Guinea, the adult literacy rate is only 63 per cent, and 67 per cent of students drop out of school before completing Grade 8.

The Anglican Church of PNG is giving a second chance at education to those who left school early. This is one learner's story:

"The literacy school has helped me more than I know," says Ronald, a learner from Sorovi literacy school in Popondetta.

The story of Ronald's interrupted education is common in PNG – growing up, he attended primary school until Grade 6, but was forced to leave early when his parents, cash croppers, did not have the money to pay for school fees, uniform, or even shoes.

"I felt like I was homeless," says Ronald. "Education was not ending forever, but it felt like it."



But now, Ronald and his classmates have resumed their education. When a literacy school started up in his community, he jumped at the chance to learn again. As vice-captain of his class, Ronald's leadership abilities have grown, and he takes pride in assisting the teacher and keeping the classroom tidy. "It has helped with my confidence, public speaking, English, and leadership skills," he says, smiling.

Ronald is now planning to start a piggery project to support himself and his family. His life is one of many lives that have been changed for the better through the long-running literacy program.

Case Study

Disaster Response

AID supported humanitarian responses in Mozambique, Democratic Republic of the Congo, Palestine, Myanmar, and Vanuatu.

AID's largest humanitarian response was in Gaza and the West Bank. Through the Diocese of Jerusalem, we funded surgery to victims of bombing in Gaza and funded a wider range of treatments in the West Bank, where many were affected by the economic crisis. AID's contribution was to a wider response by a consortium of Anglican partners that treated more than 4,000 patients.

In 2025, Myanmar was affected by conflict, floods, and an earthquake. AID's assistance, mainly in the form of cash relief, reached more than 5,000 displaced people. One participant commented on AID-funded construction of temporary shelter in Myitkina diocese: 'The violence and fire had left everyone deeply saddened and traumatized. However, we all came together and participated in the construction work. Through this collective effort, we began to relieve our stress and regain a sense of purpose.'

In Vanuatu, AID funded potable water, food relief, and psychosocial support to more than 2,600 people affected by the Port Vila earthquake.

AID didn't ignore Africa. Through the Anglican Church in the Democratic Republic of the Congo, we provided food relief to 75 families that had been displaced by conflict. To the southeast, when Nampula Diocese in Mozambique was struck by Cyclone Chido, AID funded the provision of food vouchers, tents, and sanitary kit vouchers for 215 vulnerable families.

In all the above relief distributions, local volunteers played a vital role, conducting needs assessments and assisting with the distributions.

Gender



Women often have fewer opportunities for education, income generation, and community leadership than men. AID's gender equality project in Zambia, implemented through ZACOP, ran gender awareness sessions attended by 13,237 people.

ZACOP also maintained five counselling desks across two sub-districts, processing 2,534 gender-related cases (mostly gender-based violence but including several cases of child marriage).

In Sri Lanka, our project included awareness sessions for women on health and social issues. One participant in Deniyaya explained, "Before attending, I didn't know much about breast cancer or how to check myself. Now I feel more confident talking about health issues with my family and friends".



Other projects, whilst not focusing primarily on gender, still included gender awareness sessions. Such sessions were run in Vanuatu, Kenya, and Myanmar. More generally, almost all projects funded by AID in 2025 had higher female than male participation. This shows our projects are accessible and beneficial for women and girls.

Safeguarding

Safeguarding means creating and maintaining environments that protect people (including children) from exploitation, harm, and abuse of all kinds.

This means managing risks related to sexual misconduct and harassment and child protection within AID institutionally, and in our projects. AID also continued to monitor safeguarding risks throughout 2025, including reporting on risks quarterly to our AID Board. We also prepared a Safeguarding Policy Induction Module for our Board. Both AID's and ABM's boards approved our new safeguarding policy in 2025. AID's Head of Programs led a safeguarding reflection session with ABM and AID staff in January 2025.

With partner organisations, AID staff ensured our project agreements included a section on safeguarding obligations. We followed up on key obligations, including ensuring partner staff sign a code of conduct and undertake safeguarding orientations.

Evaluation in Vanuatu

In June 2025, an evaluator visited our water and sanitation and adult literacy program sites in Vanuatu.

They found that ACOM-V had "built contextually appropriate WASH facilities like latrines and handwashing facilities, integrating its approaches with disaster risk reduction messaging".

The adult literacy classes had given confidence to people who had left school early. In one community (Wasaka), 14 early school leavers had, after attending adult literacy classes, gained sufficient confidence to return to formal schooling. In another community (Merelaen), a woman with a disability said, "I have been able to take part in ... bible readings in church and community discussions. I am no longer scared and do not feel left out."

Partnership Programs

Five of our projects were part-funded through the Australian NGO Cooperation Program of the Australian Government (ANCP). These five projects contributed primarily to targets within the following Sustainable Development Goals: SDG 1, SDG 2, SDG 4, SDG 5, SDG 6, SDG 7, and SDG 13.

Our projects with partners E-CARE, IFI-VIMROD, ZACOP, and ADSE tackled poverty (SDG 1) by establishing community groups that provided access to microcredit or grants for entrepreneurial initiatives. To tackle poverty and increase food security (SDG 2), IFI-VIMROD and ADSE also provided agricultural training. The E-CARE, ADSE, and ACOM projects installed water supplies that can be used for home gardening.

Our project with ACOM Vanuatu contributed to education (SDG 4) by providing adult literacy classes. All our ANCP projects provided the skills needed to promote sustainable development by running training on plumbing, agriculture, livestock husbandry, financial literacy, and community group governance.

Our projects with ZACOP, ADSE, and ACOM all promoted gender equality (SDG 5) by running gender awareness sessions. ZACOP additionally: conducted awareness raising about child marriage and the importance of girls staying in school, ensuring the girls received educational opportunities; improved women's livelihoods; and provided numerous leadership roles for women.

Our ACOM Vanuatu, E-CARE and ADSE Kenya projects provided clean water for drinking and domestic use (SDG 6), while ECARE also installed solar panels (SDG 7).

Our projects with E-CARE, IFI-VIMROD, ADSE and ACOM all promoted climate action (SDG 13) by running climate resilience awareness sessions and assisting communities to prepare disaster risk reduction plans.

All AID's ANCP projects complemented and extended the Australian Government's priorities in the countries and regions where the Department of Foreign Affairs and Trade (DFAT) operates. Key themes of AID's ANCP projects - climate resilience, Gender Equality, Disability and Social Inclusion (GEDSI), and poverty reduction - are also DFAT's priorities.

In Papua New Guinea, through the Church Partnership Program, the Anglican Church of PNG continues to deliver on Sustainable Development Goal (SDG) 4 – “Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all.” The Literacy and Numeracy program provided training to 15 teachers, most of them women. It also supported more than 300 learners in accessing and completing literacy and life skills training.

In our ANCP project in Zambia, ZACOP followed up on their gender awareness-raising sessions by helping community-based gender action groups to link with the local Police Victim Support Unit and health personnel. In Kenya, ADSE followed

up their disability rights awareness-raising by providing 50 people with disabilities with female goats. ACOM (Vanuatu) followed up on their disability rights awareness-raising by installing model latrines at the homes of people with disabilities.

Our projects in Zambia, Kenya, and the Philippines also supported people to increase their incomes by working with communities to establish groups to share knowledge and provide access to microcredit or grants for entrepreneurial initiatives.

Our Networks and Partners

Partners



AID maintains a wide range of partnerships and stakeholder relationships.

1. Networks

The network with which AID worked most in 2025 was the Anglican Alliance. This network coordinated Anglican donors to fund the Gaza and West Bank Conflict Relief program and assisted with other jointly funded projects, including the Myanmar earthquake response and the Mozambique cyclone response. Through a second network, CAN (the Church Agencies Network) and its humanitarian arm, CAN DO (Church Agencies Network Disaster Operations), AID accessed Australian Government funding to run a disaster preparedness project in Vanuatu, called Anticipatory Action. Through a third network, Action by Churches Together (ACT) Alliance, AID can respond to disasters in countries where we have no Anglican partners. Our most recent project through this network was the earthquake response in Syria and Turkey in 2023. Through all the above networks, AID also shares ideas and information.

2. Development Standards

In the international aid sector, the notion of locally led development is gaining momentum, with international aid agencies being encouraged to play more of a support role and to leave more decision-making to locals. AID, which has no sub-offices based in developing countries, has long believed in playing this support role, as we implement programs entirely through local church partners. AID maintains contact with our partners through regular visits, attending meetings such as the Anglican Alliance's ORAC (Oceania Regional Advisory Committee), and regular online communication. This year, we once again held an online Partner Conference to invite our partners to share their ideas and experiences with each other. Themes included locally led development, social inclusion, monitoring and evaluation, and organisational challenges.

3. Implementing Partners

AID's international development work is guided by standards set by the Australian Council for International Development (ACFID) and the Australian Government's Department of Foreign Affairs and Trade (DFAT). By complying with standards set by DFAT, AID accesses DFAT international aid funding both for community development and disaster response. In 2025, DFAT and ACFID also organised workshops, which AID staff attended.

CHIEF FINANCIAL OFFICER'S REPORT

2025 Financial Summary of ABM's Anglicans in Development (AID) Programs

For the 2025 financial year, AID recorded a deficit of \$66,838. This was primarily due to the drawdown of emergency funds received in previous year.

Total revenue for the year amounted to \$2,826,008, designated for the International Aid and Development Programs. This comprises of 43% from the Australian Government's Department of Foreign Affairs and Trade (DFAT), 39% from individuals, churches, and communities, 13% from ABM in the form of grant and trust fund and 5% from investment.

Overall, fundraising income remained stable, supported by strong emergency appeal responses and the ongoing generous support of individuals and church organisations.

During the year, AID continued to receive grants from DFAT through the Australian NGO Cooperation Program (ANCP), the Papua New Guinea Church Partnership Program (PNG CPP). The funding under the PNG CPP increased slightly compared to 2024.

Spending on AID's international programs rose by 8% compared to 2024, largely due to increased expenditure on the emergency programs.

The income statement also shows a 28% reduction in Accountability and Administration costs, and a 37% in Fundraising costs, compared to 2024. Community Education costs were also reduced significantly. These outcomes reflect the significant efforts of the management team to streamline operation by reducing staffing levels and implementing cost saving initiatives. Key improvements included consolidating design, production and web development efforts for appeals and reducing resource production costs, resulting in more efficient processes and greater operational effectiveness.

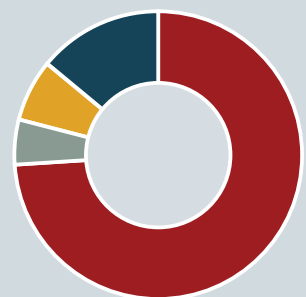
Financial Position

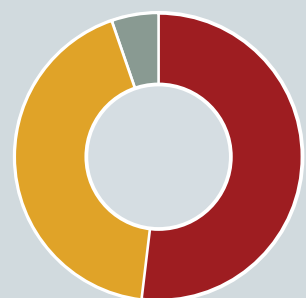

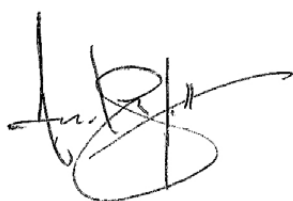
